## **Thomas G. Glick Elected Vice President of Bar Association of Metropolitan St. Louis**

### **DANNA MCKITRICK ATTORNEY HAS TEN YEAR HISTORY IN BAMSL LEADERSHIP**

Glick earned his J.D. from the University of Missouri-Columbia School of Law and his B.A. in government from the University of Texas at Austin.
